## **ONE YEAR LIMITED LUBRICATION TRUCK WARRANTY**

1. Auto Crane warrants that each of their lubrication truck products will be free from defects in material and workmanship for a period of one year from date of shipment, subject to the conditions and restrictions contained herein.
2. Auto Crane further warrants all parts furnished under this warranty for a period which expires upon the termination of the warranty onto which these parts are installed. All parts furnished outside of this warranty are warranted for a period of 30 days from date of shipment.
3. This warranty does not apply to a product that has not been installed or maintained in accordance with Auto Crane's instructions, been subjected to damage in an accident, abused or neglected during operation, repaired or modified by persons other than Auto Crane, or failed to have normal maintenance.
4. This warranty covers only equipment and parts manufactured by Auto Crane. All other components and accessories furnished with the Auto Crane lubrication truck are sold only with the express warranty, if any, of the manufacturer thereof.
5. The buyer expressly agrees that Auto Crane's responsibility in respect to warranty claims is exclusively limited solely to repair or replacement, at Auto Crane's option, of product found by Auto Crane to be defective. Auto Crane does not pay for labor charges, transportation charges, or any incidental or consequential damages connected with removal of a product deemed to be defective or with installation or replacement of repaired product. Further, Auto Crane disclaims any liability for any incidental or consequential damages, including lost or duplicated time or expense, accruing for any reason to the owner or user of any products sold by Auto Crane, whether claim is made in contract or in tort or under any warranty or in negligence or otherwise.
6. Auto Crane reserves the right to make changes in its products without incurring any obligation to incorporate such improvements in any products previously sold or in service.
7. The terms and conditions of this warranty cannot be altered without the written consent of Auto Crane.
8. This warranty does not apply to any product which has not been paid for according to the terms under which the product has been invoiced. In addition, Auto Crane will not honor any warranty claim from a customer whose account at Auto Crane is not current according to Auto Crane's payment terms.
9. The foregoing warranty is exclusive and in lieu of all other express, statutory, and implied warranties including those of merchantability and fitness for any particular purpose.

## Application of warranty

1. To make a claim under this warranty, contact Auto Crane with a description of the product and request an Auto Crane Warranty Claim Form. Merchandise should not be returned to Auto Crane without a warranty claim form.
2. After receipt of an Auto Crane Warranty Claim Form, the product should be returned, freight prepaid, to Auto Crane. If found to be defective, and if all return freight charges have been paid, or authorization to return freight collect is received, Auto Crane will repair or replace the product (our option) and return it to the customer.
3. In emergency cases where it becomes impractical to wait for warranty consideration by Auto Crane, parts will be shipped on account to the customer pending warranty evaluation. Customers without an established account with Auto Crane will be shipped parts C.O.D. Upon completion of the warranty evaluation, the customer will be reimbursed for the charges if parts are found to be warranted.
4. To make a claim under this warranty regarding other than equipment failure, (i.e. system failure, quality, or workmanship) warranty repairs must be approved in writing by Auto Crane.
5. All warranty repairs will be completed at point of manufacture, the customer should return the equipment, freight prepaid, to Auto Crane. If found to be a warranty defect, and if all return freight charges have been paid, or authorization to return freight collect is received, Auto Crane will repair the equipment and return it to the customer.
6. In emergency cases, where it becomes impractical to wait for warranty consideration by Auto Crane, the customer must receive written authorization to have equipment repaired at an Auto Crane approved repair facility. Upon completion of these repairs the customer will be reimbursed for the charges if the repair is found to be warranted.
